**All exhibits** must be for sale and must be originals (*works done in class or copied from another source will not be accepted*) and **are to be delivered to Toscana Gallery on Thursday, October 14, from 10a.m. until 12 noon.**

All hanging artwork (do **NOT** use saw-tooth hangers) **MUST** be labeled on the back with artist's name; title of work; medium; dimensions; and price. Once works have been submitted and accepted, no substitutions will be allowed. Fine art and fine crafts only.

**A reception is planned for Saturday, October 16, from 6pm until 9pm. All participating artists are required to bring food for the reception.**

**WHEN THE SHOW CLOSSES ON FRIDAY, NOVEMBER 5, ALL UNSOLD WORKS ARE TO BE PICKED UP AT TOSCANA GALLERY FROM 10A.M. UNTIL 12 NOON.**

Pieces not picked up will be taken to the SAAG storage unit, and will be available for retrieval at the discretion of the Board of Directors. Against the artist will be levied a penalty fine, which shall be paid before stored works can be released.

***Jewelry artists may exhibit at the opening reception only and must provide their own tables and display items. However, folders containing photographs of their works along with contact information may be placed at the gallery for the duration of the show.***
